

## PRIVACY POLICY

*Last Updated: January 19, 2026*

This Privacy Policy describes how Antimetal Inc. ("Antimetal", "we", "us" or "our") handle personal information that we collect through our digital properties that link to this Privacy Policy, including our website (collectively, the "Service"), as well as through social media, our marketing activities, and other activities described in this Privacy Policy.

Our services are designed for businesses and are not intended for personal or household use. Accordingly, we treat all personal information covered by this Privacy Policy, including information about any visitors to our website, as pertaining to individuals acting as business representatives, rather than in their personal capacity.

Antimetal's customers have their own policies regarding the collection, use and disclosure of their employees' personal information, and Antimetal is not responsible for our customers' handling of such information. Antimetal's handling of our customers' employee data is governed by service agreements with our employer-customers. To learn about how a particular customer handles personal information, we encourage you to read the customer's privacy statement or contact the customer directly.

### **Personal information we collect**

*Information you provide to us.* Personal information you may provide to us through the Service or otherwise includes:

- Contact data, such as your first and last name, email address, professional title, company name, and phone number.
- Profile data, such as the username and password that you may set to establish an online account on the Service.
- Other data not specifically listed here, which we will use as described in this Privacy Policy or as otherwise disclosed at the time of collection.

*Third-party sources.* We may combine personal information we receive from you with personal information we obtain from other sources, such as:

- Cloud providers, such as utilization statistics for Amazon Web Services servers and the amount you spend to access such services after you authorize access.

*Cookies and similar technologies.* Some of the automatic collection described above is facilitated by the following technologies:

- Cookies, which are small text files that websites store on user devices and that allow web servers to record users' web browsing activities and remember their submissions, preferences, and login status as they navigate a site. Cookies used on our sites include both "session cookies" that are deleted when a session ends, "persistent cookies" that remain longer, "first party" cookies that we place and "third party" cookies that our third-party business partners and service providers place.
- Local storage technologies, like HTML5, that provide cookie-equivalent functionality but can store larger amounts of data on your device outside of your browser in connection with specific applications.
- Web beacons, also known as pixel tags or clear GIFs, which are used to demonstrate that a webpage or email was accessed or opened, or that certain content was viewed or clicked.

## **How we use your personal information**

We may use your personal information for the following purposes or as otherwise described at the time of collection:

*Service delivery.* We may use your personal information to:

- provide, operate and improve the Service and our business;
- communicate with you about the Service, including by sending announcements, updates, security alerts, and support and administrative messages;

*Compliance and protection.* We may use your personal information to:

- comply with applicable laws, lawful requests, and legal process, such as to respond to subpoenas or requests from government authorities;
- protect our, your or others' rights, privacy, safety or property (including by making and defending legal claims);
- audit our internal processes for compliance with legal and contractual requirements or our internal policies;
- enforce the terms and conditions that govern the Service; and
- prevent, identify, investigate and deter fraudulent, harmful, unauthorized, unethical or illegal activity, including cyberattacks and identity theft.

*With your consent.* In some cases, we may specifically ask for your consent to collect, use or share your personal information, such as when required by law.

*Cookies and similar technologies.* In addition to the other uses included in this section, we may use the Cookies and similar technologies described above for the following purposes:

- *Technical operation.* To allow the technical operation of the Service.
- *Functionality.* To enhance the performance and functionality of our services.
- *Advertising.* To help our third-party advertising partners collect information about how you use the Service and other online services over time, which they use to show you ads on other online services they believe will interest you and measure how the ads perform.

- *Analytics.* To help us understand user activity on the Service, including which pages are most and least visited and how visitors move around the Service, as well as user interactions with our emails.

## How we share your personal information

We may share your personal information with the following parties and as otherwise described in this Privacy Policy or at the time of collection.

*Affiliates.* Our corporate parent, subsidiaries, and affiliates, for purposes consistent with this Privacy Policy.

*Service providers.* Third parties that provide services on our behalf or help us operate the Service or our business (such as hosting, information technology, customer support, email delivery, consumer research, marketing, and website analytics).

*Payment processors.* Any payment card information you use to make a purchase on the Service is collected and processed directly by our payment processor (see: <https://stripe.com/privacy>).

*Advertising partners.* Third-party advertising companies for the interest-based advertising purposes described above.

*Professional advisors.* Professional advisors, such as lawyers, auditors, bankers and insurers, where necessary in the course of the professional services that they render to us.

*Authorities and others.* Law enforcement, government authorities, and private parties, as we believe in good faith to be necessary or appropriate for the compliance and protection purposes described above.

*Business transferees.* Acquirers and other relevant participants in business transactions (or negotiations of or due diligence for such transactions) involving a corporate divestiture, merger, consolidation, acquisition, reorganization, sale or other disposition of all or any portion of the business or assets of, or equity interests in, Antimetal, our parent, our affiliates, or our subsidiaries (including, in connection with a bankruptcy or similar proceedings).

*Other sites and services.* The Service may contain links to websites, mobile applications, and other online services operated by third parties. The Service is not intended for use by anyone under 18 years of age. If you are a parent or guardian of a child from whom you believe we have collected personal information in a manner prohibited by law, please contact us. If we learn that we have collected personal information through the Service from a child without the consent of the child's parent or guardian as required by law, we will comply with applicable legal requirements to delete the information.
